Terms and Conditions:

1. I understand and agree that participating in club is a privilege and I do sign this Parental Consent and Release of Liability in acknowledgement of such.
2. I give my permission for my child to attend and participate in Awana events held here on the KGBC campus.
3. Prior to my child's involvement in Club activities, I acknowledge that involvement of my child in Awana events (including Game Time) may involve physical activity, risk of personal injury, risk of property damage, illness or even death, including but not limited to the risks arising from transportation-related activities, recreational activities, accidents in and around facilities, adverse weather conditions, injuries and illness as a result of food-borne illnesses, and allergic reactions.
4. By signing this Parental Consent and Release of Liability, I state that my child is fully capable of safely participating in all Awana event activities, and I expressly assume all risks of my Child's involvement, whether such risks are known or unknown to me at this time. I have provided any allergy/medical condition information above. I further generally release King's Grant Baptist Church and Awana Clubs International ("ACI") and its directors, officers, employees, volunteers, and agents, and any other participants at Awana events, from any and all claims that I or my Child may have against any of them, whether on or off KGBC campus. This Release of Liability is given on behalf of myself, my Child, and any heirs, family, estate, administrators, and personal representatives of me and my Child. I expressly agree that this Release is intended to be as broad and inclusive as permitted by the Commonwealth of Virginia.
5. I hereby give my consent that my child may receive medical treatment that may be deemed advisable in the event of injury, accident, and/or illness during any Awana events, and assume the responsibilities, if any. If it should be necessary for the participant to return home due to a medical or disciplinary action, we (I) will assume all transportation costs.
6. I understand that at Awana events or related activities, my child may be photographed. I hereby assign all rights to the photographs/videos made of my child by ACI or KGBC or its representatives. I hereby authorize and consent to the editing, reproduction, exhibition, and use of said photographs/videos by ACI or KGBC for promotional purposes in its publications, on its Web site and in local print media. I acknowledge ACI and KGBC's right to crop or treat the photographs/videos at its discretion.
7. I represent and warrant that I am a parent or legal guardian of the child(ren) named above, and have the full power and authority to enter into this Parental Consent and Release of Liability on behalf of my child. By signing below, I acknowledge that I have read and understand this document, and also represent that all information provided is accurate. I agree that this Release shall be governed by and interpreted in accordance with the laws of the Commonwealth of Virginia, without giving effect to its conflict of law principles. Any litigation under this agreement shall be resolved in the courts of Virginia Beach, Virginia.
